The Ketchum City Council will hold a public hearing to consider and take action on an equitable exchange of city-owned land for a portion of property owned by Sun Valley Holdings, LLC. The city-owned land is underutilized and provides no public benefit. The city-owned land only benefits the adjacent property by accommodating the power vault for sole use by the Village Market. The land exchange will allow for additional space on the northeast corner of Main and 1<sup>st</sup> streets to accommodate pedestrians and those with mobility impairments. It will also offer a wider pedestrian realm and ornamental pedestrian lighting along Main Street in front of the Village Market parking lot.
