1. Opening of Meeting

Meeting called to order at 9:00 AM by City Administrator Suzanne Frick

New Business

2. Discussion of 2-hour parking adjacent to East 1st Street/S Leadville Avenue as requested by Ken Pierce of Lallman, Felton, Peterson & Pierce, P.A., 100 S. Leadville Avenue, Suite 2.

Present at this meeting was Ken Pierce, P.A. whose office is located at 100 S. Leadville Ave, Suite 2. Pierce spoke to the Traffic Authority regarding parking near his business. It is now two-hour parking on both sides of 1st Street and Leadville Avenue. He stated that Argyros and Limelight parking is overflowing into their parking area. This is making his client and employee parking overflow into the street and his customers and employees are illegally parking and receiving tickets, he added. David Kassner said that if they switch it back to unrestricted parking the parking may fill up fast before anyone at Pierce's office can get in. Suzanne Frick stated that they would like to reach out and hear from Kentwood Hotel and Argyros to get everyone's perspective on this. If everyone agrees, it would be no problem to switch it back to unrestricted parking. If there is an issue they can regroup and discuss the issues. *The Traffic Authority will discuss this with Kentwood Hotel and Argyros before proceeding with any changes to the existing parking in the aforementioned area.*

4. Discussion of possible improvements for the pedestrian crossing of Main Street and Warm Springs Road at 6th

Additionally, he said that busses drop off a lot of people at this location and that rapid flashing beacons would be a good idea at this location. *The Group discussed the item and decided to do research to find out who they could bring on as a consultant or possibly an engineer to help out.*

5. Discussion on traffic control devices at S. Leadville and Gem Street. The Group discussed an issue brought by a Gem Street resident. The resident is seeing more motorists going down Gem Street and making a left turn on S. Leadville to avoid traffic lights. He thought there should be more control at that intersection as it makes it difficult for him to get out of his neighborhood. *The Group agreed they need the traffic counts and a traffic study done during the spring at this location prior to making any changes.*
