#### ORDINANCE NO. 1003

AN ORDINANCE OF THE CITY OF KETCHUM, IDAHO, AMENDING TITLE 12, CHAPTER 12.28, KETCHUM MUNICIPAL CODE "CITY PARKS AND PATHWAYS", SECTION 12.28.020 "CAMPING IN PARKS", BY AMENDING THE HEADING AND ADDING NEW LANGUAGE PROHIBITING CAMPING ON CITY PROPERTY OR IN THE CITY RIGHT-OF-WAY; PROVIDING A SAVINGS AND SEVERABILITY CLAUSE; PROVIDING A CODIFICATION CLAUSE; PROVIDING A REPEALER CLAUSE; PROVIDING FOR PUBLICATION BY SUMMARY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Ketchum Municipal Code Section 12.28.020 currently prohibits camping in Atkinson Park or Knob Hill Park; and

WHEREAS, the Chief of Police has requested that the Ketchum Municipal Code be amended to prohibit camping in all parks within the City of Ketchum; and

WHEREAS, upon further discussion, it has been determined that camping on any property or within any right-of-way shall be prohibited.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and the City Council of the City of Ketchum, Idaho:

SECTION 1: That Section 12.28.020 Camping in Parks of the Ketchum Municipal Code is hereby amended, altered, and changed by adding thereto the underlined language herein below and by deleting therefrom the language stricken through, to wit:

# 12.28.020 Camping in Parks Camping on City Property and in the City Right-of-Way.

No person shall camp within Atkinson Park or Knob Hill Park or sleep on City Property or in the City right-of-way within the city of Ketchum, Idaho, from ten p.m. to eight a.m.

SECTION 2: SAVINGS AND SEVERABILITY CLAUSE. It is hereby declared to be the legislative intent that the provisions and parts of this Ordinance shall be severable. If any paragraph, part, section, subsection, sentence clause, or phrase of this Ordinance is for any reason held to be invalid for any reason by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance.

<u>SECTION 3. CODIFICATION CALUSE.</u> The City Clerk is instructed to immediately forward this ordinance to the codifier of the official municipal code for proper revision of the code.

SECTION 4. REPEALER CLAUSE. All City of Ketchum ordinances or resolutions or parts thereof which are in conflict herewith are hereby repealed.

SECTION 5. PUBLICATION. This Ordinance, or a summary thereof in compliance with Section 50-901A, Idaho Code, substantially in the form annexed hereto as Exhibit "A," shall be published once in the official newspaper of the City, and shall take effect immediately upon its passage, approval, and publication.

SECTION 6. EFFECTIVE DATE. This Ordinance shall be in full force and effect upon the date of its publication as provided by law which is February 28, 2007.

### PUBLICATION OF SUMMARY OF ORDINANCE NO. 1003 CITY OF KETCHUM, IDAHO

AN ORDINANCE OF THE CITY OF KETCHUM, IDAHO, AMENDING TITLE 12, CHAPTER 12.28, KETCHUM MUNICIPAL CODE "CITY PARKS AND PATHWAYS", SECTION 12.28.020 "CAMPING IN PARKS", BY AMENDING THE HEADING AND ADDING NEW LANGUAGE PROHIBITING CAMPING ON CITY PROPERTY OR IN THE CITY RIGHT-OF-WAY; PROVIDING A SAVINGS AND SEVERABILITY CLAUSE; PROVIDING A CODIFICATION CLAUSE; PROVIDING A REPEALER CLAUSE; PROVIDING FOR PUBLICATION BY SUMMARY; AND PROVIDING FOR AN EFFECTIVE DATE.

A summary of the principal provisions of Ordinance No. 1003 of the City of Ketchum, Blaine County, Idaho, adopted on February 20, 2007, is as follows:

Section 1: Prohibits camping or sleeping on City property or in the City right-of-way from ten p.m. to eight a.m. The section being replaced prohibited only camping in Atkinson Park and Knob Hill Park.

Section 2: Provides a savings and severability clause.

Section 3: Provides a codification clause.

Section 4: Provides a repealer clause.

Section 5: Provides for publication of a summary of the Ordinance.

Section 6: Establishes the effective date of February 28, 2007.
