

**ORDINANCE NO. 1023**

AN ORDINANCE OF THE CITY OF KETCHUM, IDAHO, AMENDING ORDINANCE NO. 880 AND CHAPTER 2.20, OFFICERS' SALARIES, SECTION 2.20.010, MAYOR AND COUNCIL-SALARIES, A. AND B., OF THE KETCHUM MUNICIPAL CODE BY INCREASING THE MAYOR'S SALARY FROM \$1,500 TO \$3,000 PER MONTH AND BY INCREASING THE COUNCIL MEMBERS' SALARIES FROM \$1,250 TO \$1,666.67 PER MONTH IN ADDITION TO ADDING HEALTH, DENTAL, VISION, PERSI, LONG-TERM DISABILITY AND HEALTH REIMBURSEMENT ACCOUNT BENEFITS AND ADDING A NEW SECTION C. STATING THAT NO OTHER COMPENSATION SHALL BE AFFORDED TO THE MAYOR OR COUNCIL MEMBERS; PROVIDING FOR A SAVINGS AND SEVERABILITY CLAUSE, PROVIDING A CODIFICATION CLAUSE; PROVIDING A REPEALER CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.

**NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO:**

SECTION 1. MAYOR AND COUNCIL - SALARIES. Ordinance No. 880 and Chapter 2.20, Officers' Salaries, Section 2.20.010, Mayor and Council-Salaries, A. and B., of the Ketchum Municipal Code are hereby amended by deleting therefrom the stricken language and adding thereto the underlined language hereinbelow, to wit:

Commencing ~~January 1, 2002~~ January 1, 2008, the ~~salaries~~ compensation of the Mayor and of the members of the City Council shall be as follows:

- A. The Mayor shall receive a monthly salary in the sum of ~~One Thousand Five Hundred Dollars (\$1,500.00)~~ Three Thousand Dollars (\$3,000). Furthermore, beginning January 1, 2009 and continuing each January thereafter, the Mayor shall receive a Cost of Living Adjustment (COLA) to such salary in the same amount afforded to City of Ketchum employees. The Mayor shall also receive health benefits, dental benefits, vision benefits, long-term disability benefits and health care reimbursement account benefits in the same amount afforded to City of Ketchum employees. The Mayor shall also receive Idaho PERSI retirement benefits in the same amount afforded to City of Ketchum employees as prescribed by Idaho Code § 59-1322. If such benefits are declined by the Mayor, a monthly payment shall be made compensating Mayor for benefits in an amount not to exceed the value of the benefits; and,
- B. Each member of the Council shall receive a monthly salary in the sum of ~~One Thousand Two Hundred Fifty Dollars (\$1,250.00)~~ One Thousand Six Hundred Sixty-Six Dollars and Sixty-Seven Cents (\$1,666.67). Furthermore, beginning January 1, 2009 and continuing each January thereafter, each member of the Council shall receive a Cost of Living Adjustment (COLA) to such salary in the same amount afforded to City of Ketchum employees. Each Member of the Council shall also receive health benefits, dental benefits, vision benefits, long-term disability benefits and health care reimbursement account benefits in the same amount afforded to City of Ketchum employees. Each member of the Council shall also receive Idaho PERSI retirement

benefits in the same amount afforded to City of Ketchum employees as prescribed by Idaho Code § 59-1322. If such benefits are declined by a member of the Council, a monthly payment shall be made compensating such member of the Council for benefits in an amount not to exceed the value of the benefits.

C. No other compensation shall be afforded to the Mayor or Council Members.


SECTION 2. SAVINGS AND SEVERABILITY CLAUSE. It is hereby declared to be the legislative intent that the provisions and parts of this Ordinance shall be severable. If any paragraph, part, section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be invalid for any reason by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance.

SECTION 3. CODIFICATION CLAUSE. The City Clerk is instructed to immediately forward this ordinance to the codifier of the official municipal code for proper revision of the code.

SECTION 4. REPEALER CLAUSE. All City of Ketchum code sections, ordinances or resolutions or parts thereof, which are in conflict herewith are hereby repealed.

SECTION 5. EFFECTIVE DATE. This Ordinance shall be in full force and effect from and after its passage, approval and publication.


