

ORDINANCE NUMBER 1031

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO, AMENDING ORDINANCE NUMBER 980 AND APPOINTING LARRY HELZEL AND CURTIS KEMP TO THE BOARD OF COMMISSIONERS OF THE KETCHUM URBAN RENEWAL AGENCY; PROVIDING A SAVINGS AND SEVERABILITY CLAUSE, PROVIDING A CODIFICATION CLAUSE; PROVIDING A REPEALER CLAUSE; PROVIDING FOR PUBLICATION BY SUMMARY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, pursuant to Idaho Code § 50-2001 *et seq.*, the “Idaho Urban Renewal Law of 1965”, the City of Ketchum adopted Resolution No. 06-033 dated April 3, 2006 making the findings necessary to empower the Ketchum Urban Renewal Agency (the “Agency”); and

WHEREAS, on November 6, 2007, Larry Helzel and Curtis Kemp were elected to serve as members of the Ketchum City Council; and

WHEREAS, pursuant to Idaho Code § 50-2006, the City must establish a Board of Commissioners for the Agency to transact the business and exercise the powers established by Idaho Code § 50-2001 *et seq.*; and

WHEREAS, pursuant to Idaho Code § 50-2006(b)(2), the Mayor and City Council of the City of Ketchum desire to appoint Larry Helzel and Curtis Kemp to such Board of Commissioners.

WHEREAS, on April 6, 2006, the Mayor and City Council of the City of Ketchum passed Ordinance Number 980, appointing and designating themselves as the Board of Commissioners for the Ketchum Urban Renewal Agency; and

WHEREAS, Commissioner Steven Shafran has resigned from the Ketchum Urban Renewal Agency, leaving an unexpired term through March 31, 2008, and

WHEREAS, Commissioner Terry Tracy’s term of office on the Ketchum City Council is scheduled to expire on January 7, 2008, leaving an unexpired term through March 31, 2009; and

WHEREAS, Mayor Hall recommends Larry Helzel and Curtis Kemp be confirmed by the City Council to serve the remainder of Steven Shafran’s and Terry Tracy’s terms expiring on March 31, 2008 and March 31, 2009.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO:

SECTION 1. That the Mayor and City Council of the City of Ketchum hereby appoint Larry Helzel and Curtis Kemp to the Board of Commissioners for the Ketchum Urban Renewal Agency.

SECTION 2. SAVINGS AND SEVERABILITY CLAUSE. It is hereby declared to be the legislative intent that the provisions and parts of this Ordinance shall be severable. If any paragraph, part, section, subsection, sentence clause, or phrase of this Ordinance is for any reason held to be invalid for any reason by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance.


SECTION 3. CODIFICATION. The City Clerk is instructed pursuant to Section 1-1-3 of the City of Ketchum Municipal Code to immediately forward this ordinance to the codifier of the official municipal code for proper revision of the code.

SECTION 4. REPEALER CLAUSE. All City of Ketchum ordinances or resolutions or parts thereof which are in conflict herewith are hereby repealed.

SECTION 5. PUBLICATION. This Ordinance, or a summary thereof in compliance with Section 50-901A, Idaho Code, substantially in the form annexed hereto as Exhibit "A," shall be published once in the official newspaper of the City, and shall take effect immediately upon its passage, approval, and publication.

SECTION 6. EFFECTIVE DATE. This Ordinance shall be in full force and effect from and after its passage, approval, and publication.





Section 1: Appoints and designates Larry Helzel and Curtis Kemp to the board of commissioners for the Ketchum Urban Renewal Agency.

Section 2: Provides a savings and severability clause.

Section 3: Provides a codification clause.


Section 3: Provides a repealer clause.


