ORDINANCE NUMBER 877

AN ORDINANCE OF THE CITY OF KETCHUM, IDAHO, AMENDING CHAPTER 10.08 OF THE KETCHUM MINICIPAL CODE BY AMENDING SECTION 10.08.150.C. TWO HOUR LIMITED PARKING ZONE; REPEALING SUPERSEDED ORDINANCES NUMBERS 830; 847; 876 AND 888; REPEALING SECTIONS OF SUPERSEDED ORDINANCES NUMBER 860 SECTION 5,C; PROVIDING REPEAL SHALL NOT REVIVE ANY ORDINANCES; PROVIDING EFFECT OF REPEAL ON PAST ACTIONS AND OBLIGATIONS; PROVIDING A SAVINGS AND SEVERABILITY CLAUSE; PROVIDING A REPEALER CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, there is a need for additional time-limited parking near businesses in the Community Core (CC) District.

WHEREAS, ordinances and sections of ordinances have been superseded by others and should be repealed.

NOW THEREFORE, BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO:

SECTION 1. ORDINANCES REPEALED. The following ordinances are hereby repealed: 830; 847; 876 and 888 in their entirety.

SECTION 2. SECTIONS OF ORDINANCES REPEALED. The following sections of ordinances are hereby repealed: 860 section 5, C.

<u>SECTION 3. ENACTMENT.</u> That Chapter 10.08 of the Ketchum Municipal Code, Section 10.08.150. Subsection C. Two Hour Limited Parking Zone is hereby amended, altered, and changed by deleting therefrom the marked out language and adding the underlined language hereinbelow, to wit:

- C. Two Hour Limited Parking Zone. No owner or operator of any vehicle shall on any day, between the hours of eight a.m. and six p.m. or such other time period as designated, allow or cause such vehicle to be parked longer than two hours within a two hour parking zone, unless the vehicle properly displays a residential parking permit authorized by this subsection. The following described portions of public rights-of-way within the city are designated as two-hour parking zones:
- 1. East Avenue between Second Street and Sixth Street excluding the center of street between Fifth Street and Sixth Street;
 - 2. Leadville Avenue between Second Street and Sixth Street;
- 3. Fourth Street between Walnut Avenue and the alley between First Avenue and Second Avenue excluding the south side of the half block of Fourth Street between First and Second Avenues:
 - 4. Main Street between River Street and Sixth Street;

- 5. First Avenue between Sun Valley Road and Fourth Street;
- 6. First Avenue between Sun Valley Road and Second Street, north half block, west side;
- 7. Washington Avenue between SecondFirst Street and Fourth Street, excluding the east side of Washington Avenue between Third Street and Fourth Streets;
- 8. The east side of Washington Avenue adjacent to Lot 5, Block 16 of the Original Ketchum Townsite between Fourth-Street and Fifth Street;
- 9. 8. The east side of Washington Avenue between Fifth Street and Sixth Street;
 - 10. 9. Sun Valley Road between Spruce Avenue and First Avenue;
 - 41. 10. Second Street between Washington Avenue and Leadville Avenue;
- 12. 11. Second Street between Leadville Avenue and East Avenue north side of west end of Lot 1, Block 23 and south side of east end of Lot 8, Block 22;
- 13. 12. Second Street between East Avenue and the alley to the east of Lot 1 of Block 43 and Lot 4 of Block 42;
 - 44. 13. The east side of Main Street between Sixth Street and Eighth Street;
- 15. 14. The south side of Fifth Street adjacent to Lot 5, Block 16 of the Original Ketchum Townsite including the area between the alley and Washington Avenue;
- 16. 15. The north side of Fifth Street between Leadville Avenue and East Avenue;
- 17. 16. The south side of Fifth Street adjacent to the southwesterly half of Block 25 and commonly known as Giacobbi Square between the driveway and Leadville Avenue (between the hours of two p.m. and six p.m.);
- 18. 17. The north side of Fifth Street adjacent to Lot 1, Block 6 of the Original Ketchum Townsite including the area between the alley and Main Street;
- 19. 18. The south side of Fifth Street adjacent to Lot 4, Block 5 of the Original Ketchum Townsite including the area between the driveway and Main Street;
- 20. 19. The east side of Walnut Avenue between Sun Valley Road and Fourth Street;
 - 21. 20. South side of Fourth Street between Walnut Avenue and Spruce Avenue;
- 21. The four parking spaces and one handicap parking space on the west side of Walnut Avenue between Fourth Street and Fifth Street, directly adjacent to Lot 6, Block 45, Ketchum Townsite;
- 22. The parking spaces on the north side of Sixth Street between Main Street and Leadville Avenue, directly adjacent to Lot 1, Boulder Mountain Village Subdivision, Ketchum Townsite;
 - 23. The east side of Second Avenue between Fourth and Fifth Streets, and
- 24. The north side of Second Street between Washington Avenue and First Avenue.
- SECTION 4. REPEAL SHALL NOT REVIVE ANY ORDINANCES. The repeal of an ordinance herein shall not repeal the repealing clause of such ordinance or revive any ordinance which has been repealed thereby.
- SECTION 5. EFFECT OF REPEAL ON PAST ACTIONS AND OBLIGATIONS. This ordinance does not affect prosecution for ordinance violations

committed prior to the effective date of this ordinance, or does not waive any fee or penalty due and unpaid on the effective date of this ordinance, and does not effect the validity of any bond or cash deposit posted, filed or deposited pursuant to the requirements of any ordinance.

SECTION 6. SAVINGS AND SEVERABILITY CLAUSE. It is hereby declared to be the legislative intent that the provisions and parts of this Ordinance shall be severable. If any paragraph, part, section, subsection, sentence, clause or phrase of this Ordinance is for any reason held to be invalid for any reason by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance.

<u>SECTION 7. REPEALER CLAUSE.</u> All City of Ketchum ordinances or resolutions or parts thereof, which are in conflict herewith, are hereby repealed.

<u>SECTION 8. EFFECTIVE DATE.</u> This Ordinance shall be in full force and effect from and after its passage, approval and publication.


