## **ORDINANCE NUMBER 897**

AN ORDINANCE OF THE CITY OF KETCHUM, IDAHO, AMENDING CHAPTER 2.40 OF THE KETCHUM CITY CODE, BY DELETING SECTION 2.40.020B AND THEREBY STRIKING THE REQUIRMENT THAT THERE BE A MAJORITY OF VOTES CAST FOR A PARTICULAR CANDIDATE FOR ELECTION TO EACH COUNCIL SEAT OR A RUNOFF ELECTION; AND PROVIDING FOR AN EFFECTIVE DATE.

## BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO:

**SECTION 1:** <u>SECTION REPEALED</u>. Section 2.04.020B of Chapter 2.40 of the Ketchum City Code is repealed in its entirety.

**SECTION 2**: <u>SECTION RENUMBERED</u>. Section 2.04.020C is renumbered as 2.04.020B.

**SECTION 3**: <u>EFFECTIVE DATE</u>. This Ordinance shall be in full force and effect from and after its passage, approval and publication.
