

ORDINANCE NO. 962

AN ORDINANCE OF THE CITY OF KETCHUM, IDAHO, ENTITLED THE ANNUAL APPROPRIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2005, APPROPRIATING TO THE VARIOUS BUDGETARY FUNDS, SUMS OF MONEY DEEMED NECESSARY TO DEFRAY ALL NECESSARY EXPENSES AND LIABILITIES WITHIN EACH FUND FOR THE ENSUING FISCAL YEAR, AUTHORIZING A LEVY OF A SUFFICIENT TAX UPON THE TAXABLE PROPERTY AND SPECIFYING THE OBJECTS AND PURPOSES FOR WHICH SAID APPROPRIATION IS MADE.

BE IT ORDAINED by the Mayor and City Council of the City Ketchum, Blaine County, Idaho.

SECTION 1: That the sum of 18,226,868.00 be, and the same is appropriated to defray the necessary expenses and liabilities of the City of Ketchum, Blaine County, Idaho for the fiscal year beginning October 1, 2005.

SECTION 2: That the City Council hereby appropriates each Fund as an independent fiscal and accounting group with a self-balancing set of accounts recording cash and/or other resources together with all related liabilities, obligations, reserves and equities which are segregated for the purpose of carrying on specific activities or attaining certain objectives.

SECTION 3: That the appropriation for the General Fund is made in the following amount to each specific division or function:

Legislative and Executive, Finance and City Clerk, Legal, Planning, Contingency, General Government Building & Plant, Human Resources/Risk Management, Contract for Services, Capital Improvements, Operating Transfers Out, Police, Communications Center, Fire, Building, Ambulance, Street, and Recreation.

SECTION 4: That the appropriation for the Water and Wastewater Funds is made in the following amounts to each specific division or function:

Water Operating Fund	897,747
Water Debt Service Fund	280,588
Water Capital Improvement Fund	763,800
Wastewater Operating Fund	1,073,739
Wastewater Debt Fund	322,210
Wastewater Capital Improvement Fund	2,201,500
Total Water and Wastewater Funds	5,539,584

SECTION 5: That the appropriation for all Other Funds is made in the following amounts to each specific Fund, department or function:

Sales Tax Fund	2,400,000
Capital Improvement Project Fund	495,500
Police Trust Fund	631,000
Fire Trust Fund	80,000
 Total Other Funds	 3,606,500

SECTION 6: That a general tax levy on all taxable property within the City of Ketchum be levied in an amount allowed by law for the general purposes for said City, for the fiscal year beginning October 1, 2005.

SECTION 7: All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.




