### ORDINANCE NO. 967

AN ORDINANCE OF THE CITY OF KETCHUM, IDAHO, AMENDING TITLE 6, CHAPTER 4, KETCHUM MUNICIPAL CODE "ANIMALS GENERALLY" PERTAINING TO ANIMAL CONTROL, SECTION 6.04.030 NUISANCE; SECTION 6.04.150 REDEMPTION OF IMPOUNDED DOGS, BY DELETING CERTAIN LANGUAGE AND ADDING NEW LANGUAGE WHICH, WITHOUT LIMITATION, PROVIDES FOR REIMBURSEMENT OF COSTS OF CAPTURE, TRANSPORTATION AND STORAGE OF ANIMALS AT LARGE; PROVIDING A SAVINGS AND SEVERABILITY CLAUSE, PROVIDING A REPEALER CLAUSE; PROVIDING FOR PUBLICATION BY SUMMARY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the provisions for animals running at large do not currently provide for a fee assessed against the owners of such animals to reimburse the City for the expenditures involved in capturing, transporting and storing such animals; and

WHEREAS, the City has expended substantial resources in capturing, transporting and storing animals at large, especially dogs.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and the City Council of the City of Ketchum, Idaho:

<u>SECTION 1:</u> That Section **6.04.030 Nuisance** of the Ketchum City Code is hereby amended, altered, and changed by adding thereto the underlined language herein below, to wit:

### 6.04.030 Nuisance.

A. It is unlawful for any owner or other keeper of a dog or other animal to fail to exercise proper care and control of such animal to prevent it from becoming a public nuisance. A nuisance includes, but is not limited, to the following: (1) frequent, continuous, or untimely barking; (2) molesting passersby; (3) chasing vehicles; (4) attacking other domestic animals; (5) trespassing upon public or private property in such a manner as to damage the property; (6) defecating on public or private property of another when the defecation is not immediately removed by the keeper of the animal; or (7) allowing any accumulation of animal feces in such a manner as to affect the health and quiet enjoyment of another person.

SECTION 2: That Section 6.04.150 is added and the Ketchum City Code is hereby amended, altered, and changed by adding thereto the underlined language herein below, to wit:

## 6.04.150 Redemption of impounded dogs.

A. Any dog impounded may be reclaimed and taken from the pound animal shelter, the Ketchum Police Department or any other location at which such dog may be impounded by the owner or any authorized person so long as the impounded dog is currently licensed and the person reclaiming the impounded dog pays the person in charge of the pound animal shelter, the Ketchum Police Department or the responsible person in charge of any other location reasonable capture, transport, and impound fees in an amount determined from time to time by resolution of the Ketchum city council. All impounded dogs not redeemed within five days shall be offered for sale adoption by the animal pound shelter in an amount to be determined by the animal pound shelter plus any required license fee. All dogs that are not sold adopted or redeemed within five days excluding weekends and holidays may be destroyed in a humane manner. (Ord. 469 § 15, 1988)

<u>SECTION 3. SAVINGS AND SEVERABILITY CLAUSE.</u> It is hereby declared to be the legislative intent that the provisions and parts of this Ordinance shall be severable. If any paragraph, part, section, subsection, sentence clause, or phrase of this Ordinance is for any reason held to be invalid for any reason by a court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance.

<u>SECTION 4. REPEALER CLAUSE.</u> All City of Ketchum ordinances or resolutions or parts thereof which are in conflict herewith are hereby repealed.

<u>SECTION 5. PUBLICATION.</u> This Ordinance, or a summary thereof in compliance with Section 50-901A, Idaho Code, substantially in the form annexed hereto as Exhibit "A," shall be published once in the official newspaper of the City, and shall take effect immediately upon its passage, approval, and publication.

<u>SECTION 6. EFFECTIVE DATE.</u> This Ordinance shall be in full force and effect from and after its passage, approval, and publication.

# PUBLICATION OF SUMMARY OF ORDINANCE NO. 967 CITY OF KETCHUM, IDAHO

A summary of the principal provisions of Ordinance No. 967 of the City of Ketchum, Blaine County, Idaho, adopted on February 21, 2006, is as follows:

Section 1: Adds the allowance of any accumulation of animal feces in such a manner as to affect the health and quiet enjoyment of another person to the current list of nuisances.

<u>Section 2:</u> Provides for the recovery of costs incurred for the capture, transport, and impoundment of animals at large by the animal shelter or Ketchum Police Department.

Section 3: Provides a savings and severability clause.

Section 4: Provides a repealer clause.

Section 5: Provides for publication of a summary of the Ordinance.

Section 6: Establishes the effective date.


