

ORDINANCE NUMBER 978

AN ORDINANCE OF THE CITY OF KETCHUM, IDAHO, AMENDING KETCHUM MUNICIPAL CODE, CHAPTER 2.32, HISTORIC PRESERVATION COMMISSION, SECTION 2.32.030, BY INCREASING THE NUMBER OF COMMISSION MEMBERS FROM SIX TO SEVEN AND PROVIDING FOR A THREE-YEAR TERM FOR SUCH ADDITIONAL APPOINTMENT; PROVIDING A SAVINGS AND SEVERABILITY CLAUSE; PROVIDING A REPEALER CLAUSE; PROVIDING FOR PUBLICATION BY SUMMARY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the community interest in historic preservation is such that the Historic Preservation Commission should expand to accommodate the level of interest; and

WHEREAS, the forthcoming workload for the Historic Preservation Commission members requires an additional member; and

WHEREAS, Idaho Statute 67- 4603 states that a Historic Preservation Commission shall consist of not less than five (5) and not more than ten (10) members that shall serve terms not to exceed three (3) years.

NOW, THEREFORE, BE IT ORDAINED BY THE MAYOR AND THE CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO:

SECTION 1. That Chapter 2.32, Section 2.32.030 of the Ketchum Municipal Code is hereby amended, altered, and changed by adding thereto the underlined language herein below and by deleting there from the language stricken through, to wit:

2.32.030 Historic preservation commission.

A. There is created a historic preservation commission which shall consist of ~~six~~ seven (7) members who shall be appointed by the mayor with the advice and consent of the council.

B. All members of the commission shall have a demonstrated interest, competence or knowledge in history or historic preservation. The council shall endeavor to appoint at least two members with professional training or experience in the disciplines of architecture, history, architectural history, urban planning, archaeology, engineering, law, or other historic preservation related disciplines.

C. Initial appointments to the commission shall be made as follows: two (2) one-year terms, two (2) two-year terms, ~~two (2)~~ three (3) three-year terms. All subsequent appointments shall be made for three (3)-year terms. Commission members may be reappointed to serve additional terms. Vacancies shall be filled in the same manner as original appointments and the appointee shall serve for the remainder of the unexpired term.

D. The members of the commission may be reimbursed by the city for expenses incurred in connection with their duties. (Ord. 512 § 1, 1989; Ord. 511 § 3, 1989)

SECTION 2. SAVINGS AND SEVERABILITY CLAUSE. It is hereby declared to be the legislative intent that the provisions and parts of this Ordinance shall be severable. If any paragraph, part, section, subsection, sentence clause or phrase of this Ordinance is for any reason held to be invalid for any reason by a Court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Ordinance.


SECTION 3. REPEALER CLAUSE. All City of Ketchum Ordinances or resolutions or parts thereof which are in conflict herewith are hereby repealed.

SECTION 4. PUBLICATION. This Ordinance, or a summary thereof in compliance with Section 50-901A, Idaho Code, substantially in the form annexed hereto as Exhibit "A," shall be published once in the official newspaper of the City, and shall take effect immediately upon its passage, approval, and publication.

SECTION 5. EFFECTIVE DATE. This Ordinance shall be in full force and effect from and after its passage, approval and publication according to law.

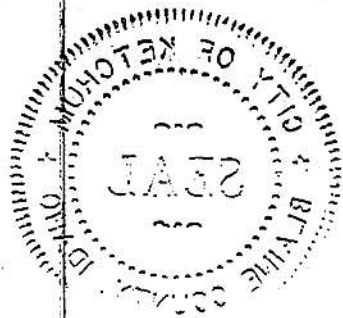

A summary of the principal provisions of Ordinance No. 978 of the City of Ketchum, Blaine County, Idaho, adopted on April 3, 2006, is as follows:

Section 1: Amends Ketchum Municipal Code Chapter 2.32, Historic Preservation Commission, Section 2.32.050, to add one (1) member to serve a three (3) year term.

Section 2: Provides a savings and severability clause.

Section 3: Provides a repealer clause.

Section 4: Provides for publication of a summary of the Ordinance.

Section 5: Establishes the effective date.




