## **RESOLUTION NO. 734**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KETCHUM, IDAHO AUTHORIZING THE MAYOR TO EXECUTE AN AGREEMENT WITH THE IDAHO TRANSPORTATION DEPARTMENT FOR THE CONSTRUCTION OF KETCHUM STREETSCAPE, PHASE 3.

WHEREAS, the Idaho Transportation Department, hereafter called the STATE, has submitted an Agreement stating obligations of the STATE and the CITY OF KETCHUM, hereafter called the CITY, for construction of Ketchum Streetscape, Phase 3; and

WHEREAS, the STATE is responsible for obtaining compliance with laws, standards and procedural policies in the development, construction and maintenance of improvements made to the Federal-Aid Highway System when there is federal participation in the costs; and

WHEREAS, certain functions to be performed by the STATE involve the expenditure of funds as set forth in the Agreement; and

WHEREAS, the STATE can only pay for work associated with the State Highway System; and

WHEREAS, the CITY is fully responsible for its share of project costs; and

## NOW, THEREFORE, BE IT RESOLVED:

- 1. That the Agreement for the Federal Aid Highway Project no. STP 2820(101) is hereby approved.
- 2. That the Mayor and the City Clerk are hereby authorized to execute the Agreement on behalf of the CITY.
- 3. That the duly certified copies of the Resolution shall be furnished to the Idaho Transportation Department.
