Project Name:	Interim Ordinance for Downtown Vibrancy and Housing

Application Type:	Interim Text Amendment to Titles 16 and 17 of the Ketchum Municipal Code
Project Description:	The Planning and Zoning Commission will hold a public hearing to consider adoption of an interim ordinance that addresses long term vibrancy and housing in the downtown and other key zone districts for a period of one year. The interim ordinance proposes the following:
	<ul> <li>Requires a minimum number of housing units in new developments in certain areas of town.</li> <li>Creates limitations on the consolidation of lots and the consolidation of individual housing units.</li> <li>Requires that when properties with existing housing redevelop the new development must include at least the same number of housing units as before.</li> <li>Clarifies parking exemptions for retail and office uses in certain areas of town.</li> <li>Revises the permitted uses for properties within certain areas of town.</li> <li>Creates additional standards for developments within certain areas of town related to amount of commercial space, size and location of housing units, and parking.</li> <li>Adds additional criteria to the Design Review approval process.</li> </ul>
