SPECIFICATIONS

-In AGREEMENT, on Page 1, REPLACE Section 1 in its entirety with the below:

1. WORK:

Contractor shall complete the Work as specified or indicated in the Contract Documents.

Milestone 1 - 2nd St to 4th St - Pedestrian & Landscape Improvements

This Milestone covers the achievement of Substantial Completion of Pedestrian and Landscape Work between 2nd and 4th Streets, including completion of new curb and gutter, all paver sidewalks on both sides of Main Street, new bulb outs and ADA curb ramps with truncated domes as well as installation of new pedestrian light poles and street trees (with tree well drainage systems), reconnection of irrigation and power to each tree and light pole and conduits. To achieve Substantial Completion, all subsurface utilities and improvements in the sidewalk and bulb out realm must be completed, and the sidewalks generally clear for unimpeded pedestrian movement. Final connections for lighting and irrigation above ground may be completed as part of Final Completion.

Milestone 2 - 4th St to 6th St - Pedestrian & Landscape Improvements

This Milestone covers the achievement of Substantial Completion of Pedestrian and Landscape Work between 4th and 6th Streets, including completion of new curb and gutter, all paver sidewalks on both sides of Main Street, new bulb outs and ADA curb ramps with truncated domes as well as installation of new pedestrian light poles and street trees (with tree well drainage systems), reconnection of irrigation and power to each tree and light pole and conduits. To achieve Substantial Completion, all subsurface utilities and improvements in the sidewalk and bulb out realm must be completed, and the sidewalks generally clear for unimpeded pedestrian movement. Final connections for lighting and irrigation above ground may be completed as part of Final Completion.

Milestone 3 – River St to 2nd St – Pedestrian & Landscape Improvements

This Milestone covers the achievement of Substantial Completion of Pedestrian and Landscape Work between River and 2nd Streets, including completion of new curb and gutter, all paver sidewalks on both sides of Main Street, new bulb outs and ADA curb ramps with truncated domes as well as installation of new pedestrian light poles and

street trees (with tree well drainage systems), reconnection of irrigation and power to each tree and light pole and conduits. To achieve Substantial Completion, all subsurface utilities and improvements in the sidewalk and bulb out realm must be completed, and the sidewalks generally clear for unimpeded pedestrian movement. Final connections for lighting and irrigation above ground may be completed as part of Final Completion.

Milestone 4 – River St to 10th St – Roadway Improvements

This Milestone includes new curb and gutter and a resurfaced road between River and 10th Streets, all utility, drainage, or other subsurface improvements, as well as installation of all traffic signal and intersection lighting improvement infrastructure. Final connections for signals, and lighting above ground may be completed as part of Final Completion.

Milestone 5 – 2nd Street Improvements

This Milestone includes the Substantial Completion of the loading ramp modifications, as well as the curb, gutter, and sidewalk improvements along 2nd Street such that pedestrians generally have unimpeded access along the sidewalk. Final pavement marking and clean up can be achieved under Final Completion.

Milestone 6 – 5th Street Sidewalk Infill & Bulbout Improvements

This Milestone includes the Substantial Completion of the curb, gutter and sidewalk improvements along 5th Street, including bulbouts with ADA ramps such that pedestrians generally have unimpeded access along the sidewalk. Final pavement marking and clean up can be achieved under Final Completion.

This Milestone covers the achievement of Substantial Completion of Pedestrian and Landscape Work between 2nd and 4th Streets, including completion of new curb and gutter, all paver sidewalks on both sides of Main Street, new bulb outs and ADA curb ramps with truncated domes as well as installation of new pedestrian light poles and street trees (with tree well drainage systems), reconnection of irrigation and power to each tree and light pole and conduits. To achieve Substantial Completion, all subsurface utilities and improvements in the sidewalk and bulb out realm must be completed, and the sidewalks generally clear for unimpeded pedestrian movement. Final connections for lighting and irrigation above ground may be completed as part of Final Completion.

Milestone 2 - 4th St to 6th St - Pedestrian & Landscape Improvements

This Milestone covers the achievement of Substantial Completion of Pedestrian and Landscape Work between 4th and 6th Streets, including completion of new curb and gutter, all paver sidewalks on both sides of Main Street, new bulb outs and ADA curb ramps with truncated domes as well as installation of new pedestrian light poles and street trees (with tree well drainage systems), reconnection of irrigation and power to each tree and light pole and conduits. To achieve Substantial Completion, all subsurface utilities and improvements in the sidewalk and bulb out realm must be completed, and the sidewalks generally clear for unimpeded pedestrian movement.

Final connections for lighting and irrigation above ground may be completed as part of Final Completion.

Milestone 3 – River St to 2nd St – Pedestrian & Landscape Improvements

This Milestone covers the achievement of Substantial Completion of Pedestrian and Landscape Work between River and 2nd Streets, including completion of new curb and gutter, all paver sidewalks on both sides of Main Street, new bulb outs and ADA curb ramps with truncated domes as well as installation of new pedestrian light poles and street trees (with tree well drainage systems), reconnection of irrigation and power to each tree and light pole and conduits. To achieve Substantial Completion, all subsurface utilities and improvements in the sidewalk and bulb out realm must be completed, and the sidewalks generally clear for unimpeded pedestrian movement. Final connections for lighting and irrigation above ground may be completed as part of Final Completion.

Milestone 4 - River St to 10th St - Roadway Improvements

This Milestone includes new curb and gutter and a resurfaced road between River and 10th Streets, all utility, drainage, or other subsurface improvements, as well as installation of all traffic signal and intersection lighting improvement infrastructure. Final connections for signals, and lighting above ground may be completed as part of Final Completion.

Milestone 5 – 2nd Street Improvements

This Milestone includes the Substantial Completion of the loading ramp modifications, as well as the curb, gutter, and sidewalk improvements along 2nd Street such that pedestrians generally have unimpeded access along the sidewalk. Final pavement marking and clean up can be achieved under Final Completion.

Milestone 6 – 5th Street Sidewalk Infill & Bulbout Improvements

This Milestone includes the Substantial Completion of the curb, gutter and sidewalk improvements along 5th Street, including bulbouts with ADA ramps such that pedestrians generally have unimpeded access along the sidewalk. Final pavement marking and clean up can be achieved under Final Completion.

- -In SPECIAL PROVISIONS, on Page 3, DELETE the second paragraph under Milestone 5.
- -In SPECIAL PROVISIONS, on Page 7, DELETE the fourth paragraph and ADD the following under OPERATIONS:

FINAL COMPLETION

Construction is expected to begin by April 15, 2024 and be completed by October 31, 2024.

The modifications and revised sheets identified herein must be used in developing the Contractor's Bid Proposal, unless replace, or changed in a subsequent Addendum. The most current revised Bid Form must be used to develop the Contractor's Bid Proposal. This letter must be attached to the inside back cover of the bidding proposal or provide acceptable acknowledgment.

FAILURE TO ACKNOWLEDGE INCLUSION OF THIS ADDENDUM SHALL RENDER THE BID PROPOSAL IRREGULAR AND THE BID WILL BE REJECTED.
